

Warranty

EF PRODUCTS **LIMITED 1-YEAR WARRANTY**

THIS PRODUCT IS INTENDED FOR RESIDENTIAL USE ONLY

This Warranty applies only in the United States and Canada to products manufactured or distributed by EF Products under the EF Products brand name. This product is backed by a one year residential warranty, excluding only expendable parts such as paint, finish and vinyl. This warranty extends only to you, the original purchaser. It is not transferable to anyone who subsequently purchases the product from you.



EF Products warrants that the product you have purchased for non-commercial, personal, family, or household use from EF Products is free from defects in materials or workmanship under normal use during the warranty period. Your sales receipt, showing the date of purchase of the product, is your proof of the date of purchase. This warranty becomes **VALID ONLY** if the product is assembled / installed according to the instructions / directions included with the product.

- During the warranty period EF Products will repair or replace (at EF Products' option) the product if it becomes defective, malfunctions, or otherwise fails to conform with this Warranty under normal use. In repairing the product, EF Products may replace defective parts with new, or at the option of EF Products, serviceable used parts that are equivalent to new parts in performance. All exchanged parts and products replaced under this warranty will become the property of EF Products. EF Products reserves the right to change manufacturers of any part to cover any existing warranty.
- This warranty **DOES NOT COVER** shipping charges, export taxes, custom duties and taxes, or any other charges associated with transportation of the parts or product. To obtain warranty service, you must contact an EF Products customer service representative at our phone number located in this manual. Any parts determined to be defective must be returned to EF Products to obtain warranty service. You must prepay any shipping charges, export taxes, custom duties and taxes, or any other charges associated with transportation of the parts or product. In addition, you are responsible for insuring any parts or product shipped or returned. You assume the risk of loss during shipment. You must present EF Products with proof-of-purchase documents (including the date of purchase). Any evidence of alteration, erasure, or forgery of proof-of-purchase documents will be cause to void this warranty.
- This warranty does not extend to any product not purchased from EF Products. This Limited 1-Year Warranty does not extend to any product that has been damaged or rendered defective; (a) as a result of accident, misuse, or abuse; (b) by the use of parts not manufactured or sold by EF Products; or (c) by modification of the product. Product on which the serial number has been defaced or removed is not eligible for warranty service. Should any product submitted for warranty service be found ineligible, an estimate of repair cost will be furnished and the repair will be made if requested by you upon EF Products' receipt of payment or acceptable arrangements for payment.
